Each party will be responsible for paying any filing, administrative and arbitrator fees in accordance with Egyptian laws.

These Terms of Service are effective unless and until terminated by either you or MoneyTag. You may terminate these Terms of Service as they apply to you at any time by ceasing to use the Site.
